Clerk Smith has completed the changes to the proposal for a request for bids from two trash service companies. This proposal will be sent out. Many local communities have moved to this. It should result in substantial savings for all residents, as well a reduction in street damage due to the weight of the garbage trucks. More information will follow.

**Planning Commission:** Member Boswell reported on the December Planning Commission meeting. The Planning Commission presented documentation with regard to updating the Zoning Ordinance. The Council Members are to look over this information and any questions will be addressed at the February meeting. The next Planning Commission meeting is January 4, 2012 (7:00 p.m.).
