**Streets:** The Council and Planning Commission are in agreement on moving forward with Phase 1 of the downtown streetscape improvement project.

**Planning Commission:** The next Planning Commission meeting is scheduled for April 10, 2017.

<u>Community Service:</u> Please note that Granger has requested that residents put their trash out by the curb by 7:00 a.m. Due to frost laws, Granger is currently sending 2 trucks to town which enables a much quicker collection of trash. Recently a number of residents did not have their trash out early enough and missed the collection. The Village has also entered into a new 5-year contract with Granger.
